The debate is resumed by the Republic of Turkey, which reads a press release of the SABAH newspaper. After the lecture of said press release, the chair suggested to points of information towards the Republic of Turkey, which ended up having only one carried out by the United Kingdom delegation, which asked: the SLAEPUC is a program that only applies to children? The Turkish delegation clarified that it applies to anyone independently from their age, class, ethnicity, beliefs, etc. After this, the chair suggested to the delegations in order to vote in order to establish which of the two working papers will be the final solution for the topic and which would present as a resolution for the first approved. Now, the results of the votations will be presented:

- 1. Working paper #1 (REPACT initiative): for democracy, this working paper passes, and will present as the main solution for this first topic. 11 votes in favor, 1 against.
- 2. Working paper #2 (RIC Plan): for democracy, this working paper passes, and it will manifest as a resolution for the first working paper. 9 votes in favor, against 3.

After reaching this consensus, the topic A was officially closed. Then, the topic B was started by the Russian Federation: violation of rights of ethnic minorities in failed states. The United States suggested sanctions towards nations, organizations and groups that promote the violation of human rights. On the other hand, the Russian Federation exposes that failed states are political bodies that has disintegrated to a point where basic conditions and responsibilities of a sovereign government no longer function properly; and, regarding the USA, it suggests that before running up to immediate sanctions, it is needed to identify what is the clear issue in a nation as well as organization in order to prevent acting based on prejudices. The Colombian Republic exhorts the other delegations to help those delegations that can be considered as failed states to recover their poor condition and reach equality. The United Kingdom as well as the Islamic Republic of Iran, expose that a failed state is a government incapable of satisfying the basic needs of its society, therefore the rights of the citizens may be violated, so it is up to the international community to aid those conditioned states and their people. Then, the State of Israel emphasizes that not only the already failed states need help but also the ones that are going into the path of becoming one need to be helped as well by the international community. Lastly, the French Republic established that the delegation will contribute for the failed state cause in order to promote the respect of human rights and therefore the construction of feasible states and societies.

The debate continued with the Colombian Republic which exposed that Colombia is an inclusive and respectful nation regarding protection of the cultural rights of the communities understood as minorities, and invites the other delegations to do the same as this nation. On the other hand, the Republic of Turkey exposed that the people corresponding to failed states should recover their cultural rights through the military intervention. The People's Republic of China, answering to the Turkish delegation, says that the military intervention as the solution for the recovery of cultural rights of minorities in failed states can only be considered as a last resource. The Islamic Republic of Iran states that intervention is not the solution, it is to promote an economical, social and cultural international aid towards those states that are in the failed state condition. The United States along with the United States delegation claimed that, if interventions are not the main solution and the failed states can no longer seek for any other solutions, what is the accurate or proper solution? The United Kingdom then exposed information about countries that possibly are failed states (Liberia, Cameroon, Sudan, Central African Republics...) whose ethnic diversity is high and even have a fragile index. Finally, the Russian Federation proceeded with the suggestion of a solution through an initiative called UNMIR, which stands for United Nations Minorities Rights. This program's main focus is to reduce the violation of rights. Also, this initiative intents to promote education as the focus on the diversity of the country, protection of minorities, and the satisfaction of basic needs, altogether in those failed states.
